IN FISCAL YEAR 2024, WE SIGNIFICANTLY INCREASED OUR ADVOCACY EFFORTS WITH A NEW DIRECTOR WHO HAS HELPED US WORK WITH COALITIONS AND WITH CITY AND STATE AGENCIES TO MAKE NEW YORK CITY MORE SUSTAINABLE AND HEALTHIER FOR WILDLIFE, AND FOR PEOPLE. WE BUILT RELATIONSHIPS WITH CITY AGENCIES TO CREATE AND ENFORCE POLICIES THAT PROTECTS WILD BIRDS AND HABITAT IN CITY PARKS AND BEACHES, WILDLIFE REFUGES, AND MORE.

WE ALSO LAUNCHED A NEW PROGRAM, NYCHA
