ADVOCACY AND ENGAGEMENT - NYC BIRD ALLIANCE'S PUBLIC PROGRAMS ENGAGE TENS OF THOUSANDS OF NEW YORKERS ANNUALLY IN LEARNING ABOUT AND APPRECIATING URBAN WILDLIFE THROUGH GUIDED BIRD OUTINGS, CLASSES, FESTIVALS, AND AN ONLINE LECTURE SERIES.
